2021 SCHS ANNUAL MEETING NO CARRY-IN - DESSERTS WILL BE PROVIDED

The Starke County Historical Society Annual Meeting will be held on Thursday, November 18 at 6:30 PM at the Knox High School Cafeteria. Due to uncertainty regarding our status with the pandemic, instead of a carry-in meal, we will **serve desserts only** which will be provided by local businesses.

The business meeting will include information about SCHS during the past two years and election of officers. There will be sign-up sheets offering all members the opportunity to be on working committees. The main program will be provided by Dean Wickert, Starke County author. Wickert's books include <u>Families from the Beginning</u> and <u>The Story Farm: How Hogs, Dogs, and Dirt Taught a POW's Family to Live</u>.

There is construction at the high school. The new main entrance and parking are now on the south side of the building. Signs will be posted. Below are directions and a map of the building.



Directions: From Highway 35, turn west at the traffic light between Walgreens and the fire station (Clabaugh Drive), go to the first stop sign (Main Street). Turn left (south) on Main Street which will be behind the 5-Star complex and along the tennis courts. The entrance to the high school parking is at the end of the tennis courts, and is not well lit at night.

Turn west (right) into the entrance and drive to one of the parking lots. There is parking on the south, west, and east sides of the building. The main entrance is nearer the west end of the building.



2021 ICE CREAM SOCIAL

HISTORY CENTER CLOSED FOR WINTER

The Starke County History Center will be closed during the winter months of January and February. Normal hours resume in March: Thursdays 10-4, Saturdays 10-2.

Spotlight on Starke County History: BASS LAKE STEAM BOATS

Steamboats evoke a romantic vision of times past. Steamers operated on Bass Lake around the turn of the 20th century. By June of 1892 the "City of Kokomo" was making hourly trips across the lake, with a capacity of 30 people. This little steamer continued to operate for a couple of years. However, in July of 1895, a windstorm swept across the lake, turning the steamer on its side as it was landing at the Shoup pier and throwing a number of its passengers into the shallow water. This is the last reference found for this particular boat. That same month (July, 1895), it was announced that the Chicago Editorial Club was putting a "handsome new steamer on the lake". There are references in the newspapers to concerts by the K. of P. band being held aboard this boat over the next two summers.

By 1898, arrangements were made to launch a large steamer near the Brabrook Hotel on June 18th, 1898. Speeches were given by Judge Beeman and Simon Bybee, with music provided by the K. of P. band. This boat was 60 feet long and could carry up to 350 passengers, making it the largest vessel to be used on the lake.



The steamers were popular, so during the winter of 1899-1900, William Atmur announced he intended to add a new steamer to the lake just for guests staying at his lodge. By September, 1900, this new steamer was complete and ready to carry passengers to any part of the lake.

By June, 1902, two trains stopped daily at Lake Park. One of the steamers met all trains at the pier. Soon there were three passenger boats on the lake - "Majestic", "Letha May", and "Myrtle". In 1906, the owner



of the "Myrtle" announced he was building a new steam boat that would float in only 13 inches of water, so that the long piers used for the current boats (at the time) would be unnecessary. In 1909, there were again three steamboats operating on the lake: "Majestic", "Letha May", and "The City of Knox" which may or may not be the boat that replaced the "Myrtle".

DID YOU KNOW?

Did you know railroads named Starke County's largest lake? The earliest reference to the name "Bass Lake" is in the June 3, 1892 edition of the Starke County Democrat.

The new station of the Chicago and Erie road, a mile and a half from Cedar Lake, will be called Bass Lake. Before long a new post office will be started there which will be named the same as the station, and perhaps the next legislature will consider the changing of Cedar to Bass Lake. Nothing like unison.

Although papers for a time would use both names, soon it was known as Bass Lake. Today many people don't even know it was originally known as Cedar Lake.
