STARKE COUNTY TRIVIA

Starke County was established in 1850. Out of the 92 counties in Indiana, that makes it the 91st county, followed only by Newton County in 1859.

FRANK HARRY ONO EXHIBIT

A recent addition to the exhibits in the Starke County History Center highlights one of Starke County's own heroes.

Frank H Ono was born in Colorado, but spent most of his 56 years in Starke County, Indiana. He was a second generation Japanese-American. His father was an immigrant from Japan, while his mother was Irish.

During WWII, PFC One volunteered to be part of the all-Nisei 442nd Regimental Combat Team, mostly made up of Japanese-Americans from Hawaii and the mainland. His bravery was evident during the unit's battle in Italy in 1944.



According to Wikipedia, "Ono advanced ahead of his unit and single-handedly defended his position against an enemy counter-attack. He then braved intense hostile fire to aid two wounded comrades and, when it became necessary to retreat, voluntarily covered his unit's withdrawal. For his actions during the battle, he was awarded the Army's second-highest decoration, the Distinguished Service Cross." The award was upgraded posthumously to the Medal of Honor on June 21, 2000.

His many awards are on display, including the Medal of Honor, Purple Heart, and the certificate signed by President Bill Clinton. Newspaper articles and pictures of this hero tell the story of his life.


In 2014, the overpass located on Highway 35 just south of U.S. 30 was renamed in honor of Frank H. Ono, one of Starke County's most decorated veterans.



This Medal of Honor recipient also joined three other legends from northwest Indiana on the South Shore Wall of Legends, posthumously, during an induction ceremony on December 19, 2014. The Wall of Legends recognizes natives of the area who exemplify "exploration, courage, creativity and innovation."

KOONTZ MILL

On the next page is an article on the Koontz pioneer family, who ran the Koontz grist mill for many years. Over those years, the structures were damaged or destroyed, either by flood or fire.

On display in the Starke County History Center is a set of four framed 3D wood-cuttings of Koontz Mills over the years. The mill is depicted in 1851, 1853, 1858, and 1897, showing the different versions of the mill plus a framed description of the mill in the different years. Additionally on display is an oil painting of Koontz Mill, hanging over the player piano in the front room.

Spotlight on Starke County History: SAMUEL KOONTZ, Sr. and Jr.

In the northern part of our county is Koontz Lake, one of the oldest centers of settlement and industry in Starke County. Today this is a noted lake resort in this part of Indiana. This article looks more closely into the pioneer family for whom the lake is named.

In 1846, four years prior to Starke County being organized, Samuel Koontz, Sr. came to this area. He purchased 160 acres located at the head of present-day Koontz Lake (originally Woodworth's Lake). Koontz built a log cabin, one of the first in that part of the county, then brought his family to Starke County the next year. According to McCormick's "Standard History of Starke County", Mr. Koontz also "brought from Ohio twenty-four head of sheep, which were the first in the county, and in order to protect them from the wolves it was necessary to keep them close in a stable, and finally they were butchered in order to keep them from being devoured by the wolves."

Although the land was wild and marshy, Koontz saw a business opportunity. The outlet for the lake ran through his property. Koontz built a dam to power an "up and down" saw mill, the first sawmill in the county. By 1851 he established the Koontz grist mill, located on the west bank of Koontz Lake. These different businesses were important to the entire county for several years. Pictured is the earliest Koontz grist mill.



One piece of Starke County trivia - Koontz's dam resulted in one of the first lawsuits in Starke County, as his neighbors complained the dam was detrimental to their farmland. But the federal courts ruled in favor of Mr. Koontz and awarded him title to all the waters of the lake. Mr. Koontz then deepened the mill race, allowing him to erect the well-known water mill, which ground grain and other products for many years.

By the time he was sixteen, Samuel Koontz, Jr. began learning the trade of miller, and two years later took charge of the Koontz mill. He operated this business until 1925. Additionally, he improved Koontz Lake as a summer resort, laying out and filling lots plus building cottages, ice houses and other facilities around the shore.



Both father and son served multiple terms as trustee of Oregon Township. Koontz, Jr. was the trustee responsible for overseeing construction of the Grovertown school in 1904. This building served as the local high school until the present Oregon-Davis High School was built. Samuel Koontz, Sr. died in 1898; Samuel Koontz, Jr. died in 1934.
